# MINUTES OF THE ANNUAL GENERAL MEETING

Minutes of the Virtual Annual General Meeting held on May 2<sup>nd</sup>, 2022.

#### Call to Order

The Annual General Meeting was called to order at 19:04 by Commander Art Meens who took the Chair. P/C Julie Ditmar acted as secretary for the meeting. The Chair welcomed D/C Ray Kirkham

Everyone took a moment of their time to remember all who have passed on in 2021/2022. It continues to be terrible and stressful time for everyone.

### **Notice of Meeting**

The Secretary then stated that the notice calling this Annual General Meeting had been duly given in accordance with the Squadron By-laws, and tabled a copy of the Notice of Meeting.

#### **Roll Call**

The Secretary made note of all members attending the meeting.

#### Quorum

It is ascertained that there are 20 members present, which constituted a quorum and that therefore the meeting, is properly constituted for the transaction of business.

# Minutes of the Annual Meeting held April 26th, 2021

Secretary Julie, has sent Bridge members a copy of the Minutes of the Annual General Meeting for the year 2021. A copy of the minutes were included with the notice of meeting mailed or emailed to each member. A motion was made by Julie and seconded by Wendy that the reading of the minutes of the Annual General Meeting held April 26<sup>th</sup>, 2021 be dispensed with and that they be approved as circulated. The motion was carried.

**Business arising out of the Minutes:** Is there any business arising from the Minutes of April 26<sup>th</sup>, 2021. There was no business arising from the minutes.

**Guests:** D/C Ray Kirkham and members of Port Dover Squadron.

Commander Art Meens presented his report followed by the reports of the Bridge Officers.

# **Commander's Report - Arthur Meens:**

It has been a year of little progress. To discuss the negatives first, the new National IT system has continued to provide challenges for membership renewal and for course registration. These challenges combined with the lockdowns for COVID have proven discouraging for our Bridge members.

On some positive notes, National has offered many courses online and the new systems seem to have saved the day for course registration and has provide a trickle of revenue for our Squadron.

Thank you to our Squadron Educational Officer Alan McKeown for continuing to be dedicated to offering courses both for our Squadron and for our District. The Moodle modules that have been in place for many years but underutilized came to the fore and help save the day with respect to courses offered online. With courses being held online, there has been limited opportunity to recruit new Officers for our Bridge. I would like to thank all those who have worked with us this year to get through what has been a challenging couple of years.

Membership has sagged by at least  $1/3^{rd}$  during Covid and the conversion to the new IT system. There appears to be no attempt to offer renewing members – those who have been lapsed over the past 2 years – an easy method of re-joining. Our Squadron will not be spending more time on this issue. It is a problem for National to solve.

Merit Marks have been submitted for the past 2 years and they have been received for distribution at our Annual meeting.

On the local front, we have finally obtained agreements to install the webcam at the lighthouse in Port Dover. We hope that by this summer, we will be able to see the lake before we trek down to enjoy it. We should also be able to enjoy some sunsets and we will have a bird's eye view of any winter storms as they attack our installation. We are still trying to find a suitable location for the weather station.

Looking forward to 2022, COVID is lessening its effect at this time. The lockdowns in China are a concern for our progress here in North America but we will remain positive and hope that the need for lockdowns do not come here. This could allow us to host a Flare Day, and perhaps hold some Social Activities. I know that Alan is anxious to get back into in person learning. The Flare Day is scheduled for July 9<sup>th</sup> at the Port Dover Marina and Bridge Yachts has agreed to be the sponsor. Ed Laevens has signed the necessary documents.

We hope to participate in the Port Dover Canada Day parade in conjunction with the Port Dover Yacht Club.

We have a minimum number of Officers for our Bridge this coming year. This will not be a problem for the Membership Officer's position as little can be done in that position but we do require an Educational Officer to co-ordinate courses with Alan and post them to our system through our Communications and IT Officer Kristen Jerry. We look forward to hosting a Social Event in 2022 but that posting has yet to be determined. A BBQ in the Fall may work.

#### **Education Officer's Report – Alan Mckeown SN:**

At the time of writing, there has been nothing new from the National Education Committee. Not surprising, with the upcoming March meeting. I will be attending on-line, as personally do not want to go to Toronto, with the proof of vaccination lifted. No agenda yet so very little anyone can say. The NEO sent out a list of questions before the meeting, which I replied to. Essentially summarizing all our IT system issues reported over the winter, courses we are running, extremely slow delivery of course materials and exams and the lack of instructors. Also, probable instructor burn out.

One thing I could not answer was squadrons intentions, if any, to get back into the classroom this spring. We are rapidly approaching the boating season and the few remaining instructors have boats to get ready. There is always a risk of a new covid variant. So, it's possible that few courses may be done before fall. Marketing department, of course wants us to sell courses in the summer. Hopefully, the new totally self study Boating 2 will be ready. Squadrons will sell it and supply chat room answers to questions. If we have volunteers...it's been tough to get tutors for the on-line Moodle courses.

At present, we have 4 squadrons offering on-line courses that have 1 instructor. Sharing the courses among squadrons has really helped with the teaching load and as one of the sole instructors, deeply appreciated. It's working very well.

It's time that we have a very deep discussion on the courses we offer, how, and when. We urgently need to recruit instructors. Creating District wide on-line courses is one option and sharing instructors.

## Secretary's Report - P/C Julie Ditmar AP:

District District Commander Ray, Commander Art, Bridge members, Squadron members and guests. As the secretary for Port Dover I have completed the monthly meeting minutes. Helped whenever needed. With COVID19 so prominent it has stopped all interaction with the Bridge and any Social events. I will continue in this position for year 2022/2023. Please everyone stay safe and healthy. I wish you all a good evening.

# Membership Officer's Report – Wendy Anes Hirschegger:

According to the database, we have 119 members comprised of:

The last several years have been particularly difficult for the CPS-ECP in terms of the changeover to the new IT system. The previous system was woefully out of date in terms of technology and increasingly hard to upgrade as browsers and other platforms (such as ecommerce payment systems) continued to evolve, and therefore clearly needed to be replaced. However, much of the contact information residing in the old database was also out of date and that caused significant problems in terms of migration to the new system which occurred on November 28, 2019. While District and Squadron Membership Officers tried to help sort out and correct the data for their own lists, this proved to be difficult in that in many cases, members had moved and/or no longer have land lines, in addition, a significant number did not have email addresses. Further, the migration to the new system also required members to "reclaim" their profiles through an unwieldy process that was also rife with technical difficulties. This was then further exacerbated by the pandemic, just as the vast majority of memberships were coming due in the spring of 2020, because of the various lockdowns. If members did try to contact the National Office, they were unable to speak to someone immediately and had to rely on return phone calls or emails. At the various levels, we continued to try to make contacts and to encourage renewals, but finally, after a year and a half of being unable to make contact or having no response from those attempts, in November 2021, the National Office decided that any memberships that had been not been renewed by 30 days after their most recent expiry date would be removed from the membership list. This has resulted in the significant drop in the official number of members at all levels, ours included. At the 2021 AGM, I had reported that our list had 210 members; now we have 119.

Not surprisingly, the huge drop in the number of members, has also resulted in a significant drop in

revenue for the CPS-ECP and hampers their ability to provide services. As such, the National Membership Committee has announced that as of April 16, 2022, when CPS-ECP members renew their membership or make any purchase, they will also be able to make an **optional charitable donation** to CPS-ECP at the same time. Income tax receipts will be issued for a minimum \$20.00 donation. The donation line will be included on the invoice. It is hoped that this initiative will both generate additional (much needed) income for the CPS-ECP as well as be a tangible incentive for members to further support the organization.

# Canadian Blood Services Partners for Life Program – Wendy Anes Hirschegger:

In November 2018, the Port Dover Power & Sail Squadron joined the Canadian Blood Services "Partners for Life" Program providing both organizations with opportunities to promote awareness of the benefits of donating blood and involvement in the community. So far in 2022, there have been 4 blood donations towards our annual pledge of 25 donations.

Blood donors are needed every day. Blood and blood products are a critical part of everyday medical care including major surgeries, medical procedures, cancer treatments and managing diseases and disorders. The Canadian Blood Services Facebook page recently shared the story of a young boy who has needed monthly transfusions since his birth because of a rare disorder. Now, in grade 9, he has received over 200 transfusions: Blood donors have saved this teen's life more than 200 times, and counting

The Chair then asked that the current Bridge Officers, other than the Secretary, step down and that P/C Bill Jerry Chair, Committee on Nominations, act as Chair of the Meeting.

- a) P/C Bill Jerry asked the Secretary if any further nominations had been filed, other than those contained in the Report of the Committee on Nominations. The Secretary replied that there were none. Motion made by P/C Bill Jerry that nominating committee report be accepted; seconded by Penny Holmes. Motion carried.
- b) P/C Bill Jerry stated that since there were no other nominations filed, there was no need for a ballot. The Chair, Committee on Nominations, declared those persons to have been duly elected to the offices set out opposite their names, to serve until the next Annual General Meeting, all in accordance with the provisions of the Squadron Bylaws.
